Teaser	You can no longer look after or raise your own child for various reasons? Then it is possible to give your child to a foster family for a certain period of time or duration.
Volltext	<p>Caregivers take a foreign child, who for various reasons can no longer be brought up by his parents themselves, for a certain time or duration into their family and care for and educate him.</p> <p>This is done as part of the help for education in full-time care through mediation by the Youth Welfare Office.</p> <p>Caregivers are carefully prepared for their task by the Youth Welfare Office and checked for their suitability. You have a legal right to advice from the responsible youth welfare office.</p> <p>Through their commitment, caregivers make a valuable contribution to youth welfare by giving children a home, education and care. In this way, they also support their parents who are unable to care for their children for a period of time or in the long term.</p> <p>In the course of the care relationship, the youth welfare office, the caregiver and the parents with custody jointly advise on what is best for the development of the child (help plan).</p>

Verfahrensablauf	<p>The parents with custody submit an application to the locally responsible youth welfare office for help with education. The Youth Welfare Office then checks whether full-time care is the appropriate help.</p> <p>The parents with custody can express wishes when selecting the foster family, for example on their general life situation or religious orientation. You can also suggest a foster family yourself (e.B relatives). However, the Youth Welfare Office must determine their suitability as a caregiver.</p> <p>The design of the care relationship is agreed by the Youth Welfare Office, the authorized person and the caregiver with the participation of the child (depending on age) or adolescents together in a help plan.</p> <p>During the duration of the care relationship, both the parents and the caregivers are cared for and supported by the Youth Welfare Office.</p>

Hinweise	<p>Care allowance:</p> <p>If the Youth Welfare Office places a child with caregivers, it undertakes to ensure the necessary maintenance of the child through care allowance.</p> <p>The care allowance is staggered according to the age of the foster child and consists of the amount for the child's subsistence and the costs of education. The care allowance is intended for expenses that are to be paid directly for the foster child, i.e. for food, clothing, rent,</p>

	<p>electricity, heating, school materials, pocket money, toys, contributions for sports clubs, etc. The cost of education is a contribution in recognition of the special educational achievements of the caregivers.</p> <p>The care allowance is paid by the Youth Welfare Office.</p>
