# Modul Sachverhalt

- a certified public accountant or
- · are a sworn auditor or certified auditor or
- have passed the examinations required for these professions.

In these cases, you will not be examined in the following areas:

- Commercial law and the main features of civil law, company law, insolvency law and European Union law,
- Business administration and accounting and
- economics.

The examination is then divided into

- 2 instead of usually 3 written examination papers, which are 4 to 6 hours long and
- an oral examination lasting no longer than 90 minutes per candidate.

You can apply to shorten the examination at the Chamber of Tax Consultants in whose district you are or will be predominantly professionally active. If you do not work, the Chamber of Tax Consultants in your district of residence is responsible.

### Erforderliche Unterlagen

- Certificate of the Chamber of Public Accountants on the appointment as a certified public accountant or the appointment as a sworn auditor, or proof that the examination as an auditor or certified auditor has been passed
- other required documents: Application for admission with curriculum vitae Proof of professional qualifications

## Voraussetzungen

- You meet the admission requirements for the tax consultant examination.
- You are active as Certified public accountant or as certified public accountant or sworn auditor or have successfully passed the examinations required for these professions.

### Kosten
