Teaser	You must report accidents involving certain work equipment or installations requiring monitoring in which a person has been killed or seriously injured immediately.
Volltext	If an accident occurs during the use of work equipment and a person is seriously injured or killed, you as an employer must report this to the occupational health and safety authority.  This applies to accidents involving the following work equipment  • Elevator systems • Pressure systems • Installations in potentially explosive atmospheres • Cranes • Liquefied petroleum gas systems • Mechanical tools for event technology  • Steam boiler plants

Erforderliche Unterlagen	Informal notification with the following information:
	<ul> <li>Address of the company</li> <li>Address of the permanent establishment or the construction/assembly site at the scene of the incident</li> <li>Date of the event</li> <li>Type of event (e.g. explosion, media leak, crash)</li> <li>Number of people injured, number of people killed</li> <li>Work equipment involved</li> <li>Approved inspection body involved (in the case of installations requiring monitoring in accordance with Annex 2 of the Industrial Safety Ordinance)</li> <li>Involved body to determine the cause (in the case of work equipment in accordance with Annex 3 of the Industrial Safety Ordinance)</li> <li>Brief description of the event and the damage that occurred (including photos and videos) Measures already taken by the employer</li> </ul>
	The occupational health and safety authority may also require you to provide the following information:
	<ul> <li>Risk assessment</li> <li>Proof that a competent person has prepared the risk assessment</li> <li>Details of the responsible persons</li> <li>Information on protective measures taken</li> <li>Proof of regular training of employees</li> <li>Operating instructions</li> </ul>
