Volltext	The risk assessment and the information on which it is based are requested by the employer and checked for completeness, plausibility and accuracy. If necessary, the protective measures implemented are checked as part of an inspection.

Kosten	Gebühr: 50€ - 270€ Fees and expenses are incurred.
