Teaser	As a winegrower, you must obtain a planting permit before planting.
Volltext	You must obtain a planting permit before you carry out any planting. If you carry out a planting on an identical vineyard as the previous grubbing-up and the resulting planting potential still exists, the planting is deemed to be approved. In this case, you do not need to submit an application.

Verfahrensablauf	• Before planting a vineyard, submit an application for permission to plant vines. • For the simplified procedure, it is sufficient for you to notify us of the uprooting and planting. • After final processing, you will receive a notification from the competent authority.
Bearbeitungsdauer	0 - 3 Monat(e) If your application is not processed within three months, the vineyard is deemed to have been approved.
Frist	You may only start planting start planting a vineyard once you have received approval. The exception to this is the clearing and planting of the same area, i.e. approval in a simplified procedure. Timely notification of grubbing-up and planting in the change notification of the EU vineyard register is sufficient.

Hinweise	Planting without an existing decision leads to an unauthorized vineyard area. This is an administrative offense that can be punished.
