Teaser	As part of the licensing procedure for the commercial arms trade, you must prove that you have the appropriate expertise. To do this, you will take a specialist examination at the Chamber of Industry and Commerce (IHK).
Volltext	<p>Usually, the examination is carried out by order of the authority to which you have applied for the weapon permit and cannot be applied for separately.</p> <p>Depending on the scope of the trade permit you are applying for, the examination includes certain categories of weapons.</p> <p>In the theoretical part of the exam, you must prove knowledge of the regulations on the trade in firearms and ammunition, the acquisition and carrying of firearms as well as the basic features of the other weapons regulations.</p> <p>In the practical part of the exam, you must demonstrate safe handling of the tested weapon categories. This includes, among other things, disassembling and assembling, naming essential parts and describing how they work.</p> <p>In order to successfully pass the specialist examination for the trade in weapons and ammunition, you need</p>

not only theoretical, but also practical knowledge.  
Therefore, extensive preparation is recommended.

If you have applied for a permit to trade in ammunition, the treatment of the common ammunition and its use in the associated firearm will be examined.

As a master gunsmith registered in the register of craftsmen, you already have the expertise and do not have to prove it again by taking an examination at the Chamber of Industry and Commerce.

## Erforderliche Unterlagen

- If applicable, notification from the authority responsible for the trading licence that the examination is to be carried out
- Government-issued photo ID for identification during the exam

## Voraussetzungen

- As a rule, the authority to which you have applied for the arms trade permit must register or pre-register you for the examination

## Kosten

You can find out the fees from the Chamber of Industry and Commerce (IHK), where you take the exam. They result from the fee schedule of the competent state authority.

## Verfahrensablauf

Normally, you apply for permission to trade in arms and are then reported for examination via the relevant licensing authority. At some chambers of commerce and industry, you can or must register yourself.

- As a rule, you will receive a notification from the authority responsible for the trading licence that the examination is to take place
- Your registration will be confirmed by the Chamber of Industry and Commerce and you will receive an invitation to the exam date
- You take the exam on site at the Chamber of Industry and Commerce
- You will receive the certificate of successful completion of the specialist examination by the Chamber of Industry and Commerce

	With the subsequent reference of the specialist knowledge, you can continue the licensing procedure for the arms trade.
Bearbeitungsdauer	<ul style="list-style-type: none"> <li>• Specialist examinations take place irregularly, so the duration between notification from the authority and the examination may vary</li> <li>• The certificate is usually available immediately or a few days after passing the oral part of the exam</li> </ul>
Frist	The certificate of expertise is indefinite and valid nationwide.

Kurztext	<ul style="list-style-type: none"> <li>• In order to be allowed to trade in arms on a commercial basis, the relevant expertise must be proven.</li> <li>• Proof of expertise must be provided by an examination before a competent examination board at a Chamber of Industry and Commerce (IHK)</li> <li>• In order to carry out the examination, the authority responsible for the approval procedure usually transmits the applicant's data to the Chamber of Industry and Commerce</li> </ul>
