Teaser	You can obtain a residence permit if you intend to take up self-employment.
Volltext	You can apply for a temporary residence permit to take up self-employment.  A residence permit is a residence title. The residence permit can only be issued for a specific purpose, such as taking up self-employment.
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Valid national passport</li> <li>• Proof of health insurance;</li> <li>• Tenancy agreement</li> <li>• Curriculum vitae and proof of qualifications for previous activities and training (diplomas, certificates or attestations)</li> <li>• Financing plan / business plan</li> <li>• 1 current biometric photo</li> <li>• Please ask your local immigration office whether you need to submit any other documents.</li> </ul>
Voraussetzungen	<p>You can only be granted a residence permit if</p> <ul style="list-style-type: none"> <li>• there is an economic interest or a regional need for the activity and</li> <li>• the activity is expected to have a positive impact on</li> </ul>

	<p>the economy in Germany and</p> <ul style="list-style-type: none"> <li>• the financing of the implementation is secured by equity capital or a loan commitment.</li> </ul> <p>If you have already reached the age of 45, an appropriate pension plan is also required.</p> <p>Furthermore, the general requirements for obtaining a residence permit must be met.</p> <p>These are in particular</p> <ul style="list-style-type: none"> <li>• a secure livelihood,</li> <li>• a clarified identity,</li> <li>• possession of a valid national passport.</li> </ul>
Kosten	Gebühr: 100€
Verfahrensablauf	<p>You can only apply for a residence permit in person at the foreigners authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• You must submit the required documents in the original and pay the application fee.</li> <li>• The foreigners authority will check whether the conditions for issuing the permit are met.</li> <li>• If necessary, other authorities will be involved.</li> <li>• If all requirements are met, the immigration authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH.</li> <li>• As soon as the eAT is ready, it will be issued to you by the immigration authority.</li> </ul>
Bearbeitungsdauer	The processing time depends on the workload at the local Foreigners' Registration Office.
Frist	Application before the current residence permit expires. It is recommended that you apply 4 to 6 weeks before your current residence permit expires. The residence permit is issued for a maximum of 3 years.
