Teaser	After successful completion of your training in Germany, your residence permit for job search can be extended for a further period of 12 months.
Volltext	If you have successfully completed a school or company-based training in Germany, you can be granted a residence permit to look for a job. The residence permit will be issued to you for a limited period directly after your previous training. An extension is possible if the maximum period of 12 months was not used at the time of the first issue. If you cannot find a job during this time, an extension is also excluded. You are then obliged to leave Germany. This residence permit allows unrestricted employment.

Voraussetzungen	You must already be in possession of a residence permit for the purpose of finding a job after successfully completing school or company training in Germany, which has not yet exhausted the maximum period of 12 months. In addition, you must meet the general conditions for obtaining a residence permit. These are in particular: • a secure livelihood, • a clarified identity, • Possession of a valid national passport.
Kosten	Gebühr: 93€ - 96€
Verfahrensablauf	You can only submit an application for a residence permit in person to the immigration authority responsible for your place of residence. • You submit the required documents in the original and pay the application fee. • The Immigration Office checks whether the grant requirements are met. • If all requirements are met, the Immigration Office will take up your biometric data (photo, fingerprints) and order the electronic residence title (eAT) from Bundesdruckerei GmbH. • As soon as the eAT is completed, it will be handed over to you by the Immigration Office.
Bearbeitungsdauer	The processing time depends on the capacity utilization in the local immigration office.
