Teaser	Your company is engaged in the commercial transport of goods or passengers and your company card has been stolen? Then you can apply for a replacement card at the relevant office.
Volltext	If your company card has been stolen, you need a replacement immediately. You can apply for a replacement card as an entrepreneur or as a person authorized to represent the company or as an authorized representative. You must provide the responsible office with proof of a theft report filed with the police when submitting the application. The business replacement card remains valid until the same date as the original stolen card - if it would have been valid for more than 6 months. Thus, the validity period does not start all over again. If the remaining validity of the card is less than 6 months, you will get the card renewed. When a replacement card is issued, the original card loses its validity. If you or another person finds the original card, you must return it to the issuing office. As an entrepreneur, you are responsible for the proper use of the card or cards. In addition, you must ensure that the company card is entered into the tachograph at the beginning and end of the use of the vehicle for your company in order to assign the use of the vehicle to your company.
