Teaser	There is a closing time for restaurants and events during which operations must be suspended. You can apply for the closing time to be lifted.
Volltext	Some countries have a closing time for restaurants and events. During this time, operations must cease. You can apply for the closing time to be lifted. The legal requirements vary from country to country.
Erforderliche Unterlagen	Informal, written justification of the existence of a public need.
Voraussetzungen	The existence of a public need must be demonstrated.
Kosten	45,00 Euro
Verfahrensablauf	• Submit an application to shorten the curfew as early as possible. • Explain in detail why you see a "public need" to lift the curfew. • The application is usually decided after one week.
Bearbeitungsdauer	Processing usually takes one week.
Frist	A deadline is not specified by law. However, it is advisable to apply for a reduction in the blocking period at an early stage.
