Teaser	Do you produce, collect, dispose of or transport commercially hazardous waste? If so, you are subject to the verification procedures under waste legislation.
Volltext	Disposal, i.e. recovery or disposal, including the collection and transportation of hazardous waste, is subject to a verification procedure under waste legislation. Waste producers as well as holders, transporters, collectors and disposers of hazardous waste are obliged to do so. Private households and small-scale producers who do not generate more than two tons of hazardous waste per year are exempt. Electronic records and register management is mandatory for all parties concerned. In individual cases, the competent authority may grant a full or partial exemption.
Erforderliche Unterlagen	An electronic signature card is required for the necessary electronic signature of the verification documents. This signature card is available from various providers.
