Volltext	Have you suffered any damage to your health as a result of a vaccination or other specific prophylactic measure? Was this vaccination publicly recommended, ordered or prescribed by law or carried out in accordance with international health regulations? If so, you can apply for benefits in accordance with the German Federal Pension Act (BVG) for the vaccination injury and the health and economic consequences of the injury. Depending on the established degree of the consequences of the injury, the benefits include • non-income-related benefits, such as basic pension, care allowance, clothing wear allowance, severely disabled person's allowance and • income-related benefits such as compensatory pension, spouse's supplement, compensation for occupational injury.

Kurztext	If a vaccination has been publicly recommended, ordered or prescribed by law or carried out on the basis of international health regulations, you will receive care in accordance with the Infection Protection Act on application due to the health and economic consequences of the vaccination damage.
