Volltext	In principle, anyone wishing to provide out-of-court legal services in the following areas must register with the competent authority: • debt collection services, • Pension advice in the field of statutory pension and accident insurance, social compensation law, other social security and severely disabled law relating to a statutory pension as well as occupational and occupational pensions, • legal services in a foreign law; if the foreign law is the law of a member state of the European Union or another state party to the Agreement on the European Economic Area, advice may also be given in the field of European Union law and the law of the European Economic Area According to § 15 of the Legal Services Act (RDG), anyone who is legally established in the territory of the European Union (EU) or the European Economic Area (EEA) for the exercise of a profession comparable to one of the legal services subject to registration may also provide this service occasionally and temporarily in Germany. http://www.gesetze-im-internet.de/rdg/__15.html http://www.gesetze-im-internet.de/rdg/__15.html
