| Volltext                      | <p>In Germany, people aged 16 and over are required to have a valid ID card. From the age of 16, you must therefore apply for a new ID card in good time before the validity of your old one expires. This applies if you are over 16 and do not have a valid passport document, i.e. passport, temporary passport. The application can be made at the citizens' office at your main place of residence. If you submit the application to another citizens' office for an important reason, a surcharge of EUR 13.00 will be added to the fee. The period of validity depends on your age:</p> <ul style="list-style-type: none"> <li>• under 24 years: ID card is valid for 6 years.</li> <li>• from 24 years of age: ID card is valid for 10 years.</li> </ul> <p>It may not be possible to issue the new ID card within the remaining period of validity. In this case, it may also be necessary to apply for a temporary ID card for the transitional period. A temporary ID card is valid for a maximum of 3 months.</p> |
