Teaser	The offering of goods (offering for sale) and catering activities in the traveling trade are exempt from the Sunday and public holiday rest period. Further exemptions can be applied for.
Volltext	Anyone who operates a travel business must generally comply with the provisions of the Shop Closing Time Act (LadSchlG) and the Lower Saxony Public Holidays Act (NFeiertagsG). An exception to the Sunday and public holiday rest applies to the offering (offering for sale) of goods as well as to hospitality activities in the travel industry. In addition, the exemptions apply to self-employed traders who visit other persons in the course of their business operations.
