Volltext	Any person moving onto an inland waterway vessel which is entered in a shipping register in the Federal Republic of Germany must register with the competent authority. The shipowner of a seagoing vessel entitled to fly the federal flag must register the master and crew members of the ship at the beginning of the employment, employment or training relationship. The obligation to register ship's crews does not exist as long as these persons are registered for accommodation in Germany.
