Teaser	If you want to operate a prostitution business through a proxy, you need a proxy permit as a business.
Volltext	Anyone who wants to operate a prostitution business by a person appointed as a representative requires a representation permit. The representative permit is granted to the operator for the person appointed as a representative. It may be temporary.
Erforderliche Unterlagen	There may be documents needed. Please contact the competent authority.
Voraussetzungen	• Minimum age of 18 years for the person designated as a substitute • Reliability for the operation of a prostitution business
Kosten	Depending on the time spent, at least 200,00 Euro.
Verfahrensablauf	Permission must be applied for at the competent authority.
Bearbeitungsdauer	
Frist	If the prostitution business is no longer carried on by the person appointed as a representative, the operator must immediately notify the competent authority.

Hinweise	For processing, the person to be reported must agree to the background check and cooperate (see notes in the Prerequisites module).
