Then you can qualify in Germany to acquire the theoretical and practical knowledge you lack. This qualification is also possible in the course of employment in Germany.</p> <p>You can obtain a residence permit for the period of qualification in the context of employment if you undertake to submit an application for a determination of equivalence or the granting of a professional license. You must actively participate in the recognition procedure in Germany and present a concrete job offer or an employment contract.</p> <p>The Federal Employment Agency must approve your employment. As part of the approval process, it checks, among other things, that the employment does not take place under less favorable working conditions than the employment of comparable domestic employees. - Residence permit on the basis of a recognition partnership
- Prerequisites: German language skills, which generally correspond to level A2 Employment contract and specific job offer for qualified employment
- Non-qualified employment is possible in regulated professions The Federal Employment Agency must approve the employment Private law agreements with the employer, for example Obligation of the applicant to submit an application for determination of equivalence after the title has been issued Enabling of qualification measures by the employer Suitability of the employer to carry out qualification measures Confirmation from the Central Office for Foreign Education (ZAB) of the existence of a foreign professional qualification: at least two years of training or University degree recognized in the respective country
- Residence permit for the recognition of professional qualifications during employment is limited in time, it is issued for the duration of the approval of the Federal Employment Agency (BA), but for a maximum of 1 year.
- A fee is charged for issuing the residence permit, the time and form of payment vary depending on the authority
- Responsible: competent foreigners authority
