Comparability is based on the assessment recommendations of the Central Office for Foreign Education. The internship must correspond in terms of subject and level to the degree course or university degree.</p> <p>You cannot take up employment during your stay.</p> <p>If you have not yet reached the age of 18, the person</p>

obtained a university degree in the last 2 years before submitting the application, would like to complete an internship in Germany and have already concluded an internship agreement with a German institution

- third countries are countries outside the European Union (EU) and the European Economic Area (EEA)
- Internship must correspond to the subject of the (completed) course of study
- The host institution must undertake to bear the costs incurred by public bodies up to 6 months after the end of the internship agreement for living expenses of the person from abroad during an unauthorized stay in Germany and deportation
- Internship must be equivalent in terms of subject and level to the course of study or university degree
- It is not possible to take up employment during the stay
- Temporary residence permit for the agreed duration of the internship, but for a maximum of 6 months
- Minors require the consent of a person entitled to personal care if they plan to stay for the purpose of a study-related internship
- A fee is payable for the issue of the residence permit; the time and form of payment vary depending on the authority
