A company that is neither entered in the list of consulting engineers (at the registered office of the company in Lower Saxony) nor in the corresponding list in another federal state (at the registered office of the company in the other federal state) may, as an external company, use the professional title "Consulting Engineer" in Lower Saxony in its name or in its company, if it is entered in the list of foreign companies or in the corresponding directory in another federal state.
