Teaser	If the current management stops or changes, you must report this to the Chamber of Skilled Crafts.
Volltext	If the current management ends or there is a change, you must report this to the Chamber of Skilled Crafts. A new manager must then be appointed immediately. The owner of the business or an employed person who has the necessary technical qualifications can take on the role of business manager. The required proof of qualification for the professional and technical management of the business can be provided by a master craftsman's certificate for the craft to be practiced or a related craft, as well as by an equivalent domestic or foreign professional qualification or an exemption permit or authorization to practice. The tasks of the management include, among other things • to control, supervise and monitor the technical work process and not to limit themselves to merely checking the work results, • directing employees and giving the necessary instructions, • to prevent and, if necessary, correct deficiencies in the execution of the work, • to ensure that there are no violations of legal regulations or operating instructions,

	• regularly visit the individual work sites to monitor the execution of the work, • be available at all times during working hours and be available and ready for action at short notice in urgent and emergency situations.

Voraussetzungen	The company management leaves the company, moves to another location or resigns from their position.
Kosten	The specific fee can be found in the Chamber of Crafts' schedule of fees, which is available on the Chamber's website.
Verfahrensablauf	• Inform the Chamber of Skilled Crafts responsible for the business about the departure or change of management. • You can make the notification as the owner of the business subject to licensing or as an employed manager. • To maintain the business, you must apply to the relevant Chamber of Skilled Crafts for the new management to be entered in the Register of Skilled Crafts.

Frist	The deregistration of the company management must be reported before the change or departure.

Kurztext

- Notification of the dismissal of the company management to the Chamber of Skilled Crafts - Acceptance
- The management of the company, which is responsible for professional and technical management, is recorded in the Register of Craftsmen.
- Management can be carried out by the owner of the business or an employed person who is qualified to do so. The required proof of qualification can be provided by a master craftsman's certificate for the craft to be practiced or a related craft, or alternatively by an equivalent domestic or foreign professional qualification or an exemption permit or authorization to practice.
- If the company management ceases or changes, this must be reported to the relevant Chamber of Skilled Crafts.
- Responsible: Chamber of Skilled Crafts in whose district the commercial establishment is located
