Volltext	Adult and further education institutions within the meaning of the Lower Saxony Adult Education Act are basically free in their education, the independent design of their offer and the selection of staff. Adult education centres, state institutions and adult education centres have the option of being recognised for receiving financial aid from the state. Grant eligibility does not imply general government permission or recognition.
Erforderliche Unterlagen	The application for recognition of grant eligibility must contain information and evidence that reflects the existence of the requirements of § 3 NEBG.
