Teaser	If, as a citizen, you surrender weapons and/or ammunition that require a permit, you must notify the competent authority within two weeks.
Volltext	If you leave your weapon and/or ammunition to another person, you must report this to the competent firearms authority within two weeks. The competent firearms authority will then delete the entry for the weapon and/or ammunition from your firearms possession card (WBK) and, if applicable, from your European firearms pass. You don't have to display it if you • leave substantial parts of the weapon for embellishment or similar work to be carried out and then receive them back after completion of the work, • provide weapons and/or ammunition as part of a
