Kurztext	• European election Determination of the final election result • votes cast for the respective list election proposal are counted by the election committee after the end of the election period • subsequently, the district or city election committee determines how many votes were cast in the districts or independent cities for the individual election proposals; these election committees have the right of verification • thereafter, the Land election committees determine the votes on a Land basis • Finally, the Federal Election Committee determines how many votes have been cast for the list election proposals, how many seats are allocated to which list election proposal and which candidate has been elected. • responsible: Election committee, district or city election committee, Land election committee, Federal election committee
