Teaser	If you have a temporary permit to operate a prostitution business and would like to extend it, you must apply to the competent authority.
Volltext	If you operate a prostitution business (prostitution establishment, prostitution agency, prostitution vehicle or prostitution event) and have been granted a temporary permit, you can apply to have it extended, provided that the conditions for granting the permit continue to apply.
Erforderliche Unterlagen	Sole proprietorship (natural person): • Identity card, passport, electronic residence permit if applicable • Operating concept • Certificate of good conduct for submission to an authority according to document type "0", or European certificate of good conduct Companies (legal entities) e.g. GmbH: • Current excerpt from the commercial register / register of cooperatives • Copy of the articles of association • Operating concept • Identity card, passport, electronic residence permit for the legal representative if applicable • Certificate of good conduct for submission to an authority according to document type "0" for the legal

Voraussetzungen	• The relevant requirements of the original permit are still fulfilled

Verfahrensablauf	• You submit the application for renewal of the permit to operate a prostitution business and the relevant documents to the competent authority. • The competent authority will review the application and, if necessary, carry out a new background check. • If the check is positive, the competent authority will extend the permit.

Hinweise	Operating a prostitution business without a valid permit is an administrative offense.
Rechtsbehelf	Appeal (appeal may be excluded depending on national law), administrative court action
Kurztext	• Prostitution business Operation extension • The operation of a prostitution business requires a permit • If the permit was issued for a limited period, it can be extended upon application • Prerequisite: the relevant requirements are still met • Responsible: Responsibility depends on the respective state law
