Teaser	If you have a temporary prostitution permit to operate a prostitution business and would like to extend it, you must apply to the competent authority.
Volltext	If you operate a prostitution business through a proxy and have a temporary prostitution permit, you can apply to have this extended. The prerequisite for the extension is that the relevant requirements continue to be met.
Erforderliche Unterlagen	<p>Permit according to § 12 ProstSchG of the operator of the prostitution business</p> <p>Surname and first name of the person to be checked.</p> <p>If applicable, the person to be checked must complete the application section "Verification of the reliability of persons working in the prostitution trade".</p> <p>An existing permit pursuant to Section 12 ProstSchG or an application pursuant to Section 12 ProstSchG must have a link to the application for a prostitution permit</p>
Voraussetzungen	The relevant requirements of the original permit are still fulfilled
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law.
Verfahrensablauf	You submit the application for renewal of the proxy

	The competent authority will check the documents and, if necessary, carry out a new background check.
	If the check is positive, the competent authority will extend the deputy permit.

Hinweise	The operation of a prostitution business by a proxy without a valid permit constitutes an administrative offense.
Rechtsbehelf	Appeal (appeal may be excluded depending on state law), administrative court action
