Volltext	Since 1 January 2007, last owners of passenger cars and light commercial vehicles (i.e. vehicles for the carriage of goods up to 3.5 tonnes) have had the possibility to return the end-of-life vehicles they wish to dispose of to the manufacturer or importer free of charge. They are obliged to take back end-of-life vehicles and must set up a comprehensive take-back system themselves or through commissioned third parties. End-of-life vehicles from which essential parts or components or electronic control units have been removed and which were not registered in the European Union at least 1 month before the final decommissioning are exempt from free take-back. If you, as the vehicle owner, would like to have your disused vehicle permanently withdrawn from circulation, leave it to one of the competent authorities for disposal. There you will receive a certificate of destruction, which must be presented to the vehicle registration office for deregistration.

Ansprechpunkt	The responsibility lies with a recognised acceptance or return point or a recognised dismantling company. Furthermore, you can return your old car to the manufacturer or importer free of charge.
