Teaser	Which catering businesses are considered "temporary", when and under what circumstances must they be registered?
Volltext	<p>A temporary catering business is operated by anyone who, on a commercial basis, for consumption on the premises</p> <ul style="list-style-type: none"> <li>• serves drinks and/or</li> <li>• serves prepared food,</li> </ul> <p>if the restaurant is open to the public or certain groups of people and is only operated temporarily for a specific occasion such as a celebration, anniversary or other event.</p> <p>Anyone wishing to operate a restaurant business temporarily for a specific occasion must notify the competent authority for the location in question in writing using the form in accordance with Section 2 (2) BbgGastG (notification of a temporary restaurant business - Gagev) two weeks before the start of the business.</p> <p>This notification must also state</p> <ul style="list-style-type: none"> <li>• what type of establishment it is and</li> <li>• whether it is intended to offer alcoholic beverages.</li> </ul> <p>The following types of establishment may be considered</p> <ul style="list-style-type: none"> <li>• Snack bar</li> <li>• public house</li> <li>• Restaurant</li> </ul>

	<ul style="list-style-type: none"> <li>• Pub and restaurant</li> <li>• Open-air bar area (beer garden)</li> <li>• café</li> <li>• bar</li> <li>• with music performance</li> <li>• with dancing</li> <li>• Wine tavern</li> </ul>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• The notification is made on the "Gagev" form</li> <li>• Identity card or passport for identification purposes</li> <li>• Foreigners who are not citizens of an EU member state or an EEA member state require a residence permit from the responsible immigration authority, according to which they are permitted to exercise the trade under immigration law</li> </ul>
Voraussetzungen	The notification must be made for the serving of alcoholic and/or non-alcoholic beverages as well as for the serving of food at temporary activities, such as club parties.
Kosten	Certificate of receipt of the notification of a temporary catering business: €38.40 in accordance with the Ordinance on Administrative Fees in the Division of the Minister for Economic Affairs, Labor and Energy (MWAEGebO)
Verfahrensablauf	<p>The notification must be submitted to the competent authority two weeks before the start of operation.</p> <p>The following authorities are involved by the trade authority:</p> <ul style="list-style-type: none"> <li>• Food monitoring authority</li> <li>• Lower building supervisory authority</li> <li>• Environmental department of the independent cities, independent municipalities and offices</li> <li>• tax office</li> </ul>

Zuständige Stelle	<p>Local regulatory authorities according to § 1 BbgGastGZV.</p> <p>The duties of the local regulatory authorities are carried out by the local authorities, the independent municipalities, the association municipalities, the co-administrating municipalities, the co-administered municipalities and the independent cities (§ 3 of the Regulatory Authorities Act - OBG)</p> <p>This procedure can also be handled by a "single point of contact". The "Single Point of Contact" is a special service offered by the municipalities and the state for service providers.</p>
