| Teaser | In order to be allowed to offer your services in Germany, you must be registered in the company register of a chamber of architects. |
| Volltext | Companies which are not entered in a company register of a chamber of architects in the Federal Republic of Germany (foreign companies) may use in their company name or in their name the professional titles, word combinations or similar professional titles mentioned in § 1 of the Brandenburg Architects Act if they are authorised under the law of their country of origin to use these or comparable professional titles in their company name or name. The companies must notify the Chamber of Architects of the initial provision of services in advance. |
| Erforderliche Unterlagen | <ul style="list-style-type: none"> • Publicly certified, i.e. notarial copy of the articles of association or partnership agreement, in which the requirements of § 7 para. 2 sentence 1 BbgArchG, in the case of partnership companies only number 7, are regulated. • Proof of the existence of professional indemnity insurance that meets the minimum requirements of § 10 BbgArchG (proof must expressly state that the company itself is the policyholder). • Proof of entitlements to use the professional title. • List of all partners with information on their respective professional affiliation. • Copy of fee payment receipt. |
| Voraussetzungen | <ul style="list-style-type: none"> • Entry in a special register with the Brandenburg Chamber of Architects is made on the basis of notification of commencement of activity, if the company proves the existence of liability insurance and the professional obligations applicable to the professional members according to § 25 Brandenburg Architects Act are observed by the company. Chamber of Architects shall prohibit such partnerships or companies from using the professional title if they do not prove, on request, that:

- they, their partners or their partners or legal representatives lawfully carry out the activity in question in accordance with the law of the home country of the company; and
- the partnership or articles of association or the articles of association meet the requirements pursuant to § 8 or § 9 (2) nos. 1 to 8 and there is sufficient liability insurance for their activities in the State of Brandenburg

- By being included in the special list, the Society does not become a member of the Chamber of Architects. External partnerships or companies must notify the Chamber of Architects of the initial provision of services in the State of Brandenburg in advance.
- List of companies: adequate liability insurance
- List of partnerships: for the duration of registration and beyond 5 years after cancellation
- Amount of minimum insurance sums: 1,500,000 euros for personal injury and 250,000 euros for property damage and financial loss
