Teaser	You can find out how the European elections are conducted here.
Volltext	You cast your vote on a ballot paper. You will receive this from the election committee when you enter the voting room. With the ballot paper, you then go individually into the voting booth. There you mark your desired list election proposal with a cross or otherwise. Then fold the ballot paper so that your mark cannot be seen. The secretary of the electoral committee will then check whether you are listed on the electoral roll, if necessary after you have presented your election notification or your ID card on request. If so, you may place your ballot paper in the ballot box. The clerk will then note that you have cast your vote.

Voraussetzungen	To vote, you must be eligible to vote and be on the electoral roll.

Verfahrensablauf	The European election is conducted as follows: • Voter enters the voting room, observer hands out ballot papers, • Voter marks and folds ballot paper in polling booth, • Voter goes to the voting table with folded ballot paper, • Election committee checks eligibility to vote against the electoral roll (if necessary by presenting an identity document), • Voter throws folded ballot paper into the ballot box.

Kurztext	• European Election Procedure • Voting is by official ballot paper • ballot paper is handed out on entering the voting room • the voter then enters the voting booth individually • the desired election proposal is clearly indicated by a cross or in some other way • then the ballot paper is folded in the voting booth • the voter shall produce the ballot paper on request or identify himself or herself • if the voter is listed in the electoral roll, the ballot paper may be placed in the ballot box • the clerk shall then record the vote. • responsible: Election Committee
