Teaser	If you drive a registered vehicle on public roads, you must always have the registration certificate part I with you. This is the former vehicle registration certificate.
Volltext	You may only use a vehicle subject to registration on public roads if it has been registered for this purpose by the competent registration authority. Proof of registration is the registration certificate part I, which the driver must always carry with him or her. The registration certificate is the main identification document during traffic checks. It is a document that has been introduced throughout the European Union (EU). The registration certificate part I contains the most important information about the vehicle and the vehicle owner. The vehicle registration certificate used to fulfill this function. Both natural and legal persons, for example companies, can register the vehicle.
Erforderliche Unterlagen	State of Brandenburg: For an issue outside of an admission procedure: • Identity card or passport. In case of representation, power of attorney. • Presentation of old ZB I or, if lost, an affidavit or theft report. • Presentation of ZB II.

Voraussetzungen	The requirements for the registration of a vehicle must be met.
Kosten	State of Brandenburg: 11.10 € for an issue of the ZB I outside the approval procedure.
Verfahrensablauf	With "i-Kfz" you can apply for the registration certificate part I digitally. The registration certificate and provisional registration certificate are immediately made available online and must be downloaded or sent to yourself by e-mail within 30 minutes. You may drive on the road with this certificate for 10 days. If the provisional registration certificate is not retrieved within 30 minutes, you will not be able to drive immediately. The registration certificate Part I will be sent to you by post together with Part II and the stickers for affixing to the license plate. If you apply in person at the registration office, you will receive the registration certificate immediately.
Bearbeitungsdauer	State of Brandenburg: Admission procedures are processed directly. However, there may be waiting times for an appointment.
