Volltext	The establishment of a second branch office as a test engineer in the Federal Republic of Germany requires the approval of the accreditation authority.
Erforderliche Unterlagen	The application must be accompanied by the evidence required for approval, in particular information on 1. the responsibility for the activity in the secondary establishment, 2. the employees who are to be involved in the inspection activity and 3. to ensure the supervision of proper construction work.
Voraussetzungen	If you want to set up a secondary establishment, you must fulfill all the requirements that are also necessary for a main establishment.
Kosten	Fees according to tariff item 7.1.2 of the Brandenburg Building Fee Regulations - €200
Verfahrensablauf	• The application for approval to establish a second branch office must be submitted to the approval authority for test engineers for fire protection. • Submission of proof of the approval requirements. • Examination of the approval requirements by the
