Teaser	The Bayerische Rechtsanwalts- und Steuerberaterversorgung grants pension benefits in old age, in the event of occupational disability and to surviving dependants. To do so, it requires certain information from the new member.
Volltext	<p>The Bavarian Lawyers' and Tax Consultants' Pension Fund (BRAS_tV) is responsible for</p> <ul style="list-style-type: none"> • Lawyers and tax consultants in Bavaria • Patent attorneys with offices in Bavaria, Hamburg, Hesse, North Rhine-Westphalia or Rhineland-Palatinate. <p>The BRAS_tV is an institution under public law with administrative autonomy and has the task of providing for its members in old age and in the event of occupational disability, as well as for the member's surviving dependants.</p> <p>The pension fund is part of the statutory pension scheme and thus the first pillar of old-age provision.</p> <p>Members of the BRAS_tV acquire their pension entitlement by paying compulsory contributions and/or voluntary additional payments.</p> <p>Compulsory membership lasts for the entire period of membership in the professional association (for patent attorneys, for the duration of the existence of the registered office in the area of responsibility).</p>

	<p>To verify compulsory membership, data must be submitted via the survey form.</p> <p>There is a very limited possibility of exemption from compulsory membership of the pension fund.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Proof of membership of one of the relevant professional chambers <p>The data transfer in accordance with Art. 39 VersoG is carried out by the respective professional association to the Bayerische Rechtsanwalts- und Steuerberaterversorgung</p>
Voraussetzungen	<ul style="list-style-type: none"> • Compulsory membership of one of the bar associations or chambers of tax consultants in Bavaria • Compulsory membership of a chamber of patent attorneys and a registered office in Bavaria, Hamburg, Hesse, North Rhine-Westphalia or Rhineland-Palatinate • No occupational disability

Verfahrensablauf	<p>After registration with the professional chamber, the membership data is transferred from the professional chamber to the BRASStV.</p> <p>At the start of membership in the BRASStV, the new member must complete the "Membership survey form" and send it to the BRASStV. The completed survey form (see under "Forms") can be sent by post or electronically (see under "Online procedure"). The survey form is required for further information relevant to membership, such as the amount of income subject to contributions, possible participation in the SEPA direct debit procedure, affiliation to another pension fund in the profession.</p> <p>The member will then receive a membership notification from BRASStV by post.</p>
