Volltext	Construction advice is a service where the responsible authority helps you to better place your construction project in the legal context of your building plot. In particular, planning law and individual aspects of building regulations (e.g. setback areas) are examined together with you. The aim is to find out whether the idea of your construction project could be implemented in principle and to better prepare a possible application.
Erforderliche Unterlagen	The responsible office will inform you when you make the appointment.
Voraussetzungen	You are a building owner or are planning a construction project
Kosten	32.80 EUR per half hour or part thereof
Verfahrensablauf	You make an appointment. (Please note the individual requirements of the respective district as to whether the appointment will take place by telephone or on site) If an on-site consultation at the district office has been arranged: You appear at the appointment and present any necessary documents You will receive construction advice. You pay the fees.
Bearbeitungsdauer	The duration of the consultation depends on the type and scope of your request.
