Teaser	If you want to set up gaming machines with a chance of winning for a commercial use, you need a permit.
Volltext	You need a permit to set up and operate gaming devices that are equipped with a technical device that affects the outcome of the game and that offer the possibility of winning. With a permit to set up gambling machines with a chance to win, you can set up gambling machines throughout Germany. Each installation location must be checked and approved by the competent authority for its suitability. Gambling machines may only be set up once permission has been granted.
