Kosten	The granting of an exceptional permit according to § 7 (2) of the 32nd BImSchV is subject to a fee according to § 1 paragraph 1 of the environmental fee regulations (UmwGebO) of December 5th, 1995 (HmbGVBL 1995, p. 365) in the currently applicable version in conjunction with No. 1.3. 24 of Annex 1 to the general fee schedule. Confirmations (toleration, approval, rejection of night work) are in accordance with § 2 Fees Act (GebG) of March 05, 1986 (Hamburg Law and Ordinance Gazette 1986 p. 37) in the currently applicable version in conjunction with paragraph 5b of Annex 1 to the GebG charges apply.

Bearbeitungsdauer	The granting of the exemption depends on the complexity of the individual case.
Frist	Application: 2 weeks before the start of the measure
