Teaser	If you want to take on the tasks of a weapons manufacturer or dealer as a representative, you need a permit.
Volltext	If you want to take on responsibility for the tasks of a weapons manufacturer or dealer as a representative, or if you want to take on the management of a branch or a dependent branch office in the weapons manufacturing or weapons trading business, you need a special permit. To obtain this permit, you must submit an application to the competent authority at the location of the respective business.
Erforderliche Unterlagen	Copy of valid identification document (e.g. identity card or passport) If applicable: Residence permit with entitlement to self-employment Proof of expertise Tax clearance certificate If applicable: Commercial register extract If you are applying for a legal entity, such as a GmbH, KG or OHG, you must submit the above-mentioned documents (except personal

	documents) for both the legal entity and each natural person authorized to represent it, such as the management

Kosten	25% of the framework fee of 105 EUR - 1,375 EUR
Verfahrensablauf	You apply for permission and submit the necessary documents. The application can be made informally. You can submit the application by post, email or by putting it in your mailbox. The responsible authority will examine your application and, if necessary, request any missing documents from you. The responsible authority will inform you of the decision in writing.
Bearbeitungsdauer	Up to several months
Frist	The permit expires if the activity is not started within one year of being granted or is not carried out for one year. Extension of the deadline is possible for special reasons.
