Teaser	Have you applied for a permit for a facility that requires a permit? Then you can also apply to start construction of the facility early.
Volltext	If you want to build a facility that requires approval before it is approved by the responsible authority, you must apply to the responsible authority for approval for early construction. The responsible authority can revoke the approval for early construction at any time. The approval can be subject to conditions or can be granted conditionally if you still have to meet certain requirements. The conditions are intended to ensure that the facility can be dismantled if it is not approved. The responsible authority may require you to provide security. Security may include, for example, the deposit of money or securities or guarantees.

Erforderliche Unterlagen	Application for approval for early construction of a facility requiring approval required drawings, plans, reports Explanations of the system if necessary, other documents that you can obtain from the responsible authority
Voraussetzungen	You must have submitted an application for approval and construction or significant changes. You can apply for early commencement of construction within the application or subsequently The competent authority must be able to adequately assess the impacts of the planned facility from the application and the required documents. Your application must demonstrate a legitimate interest in starting early. As an applicant, you must undertake to compensate for all damage caused by the premature construction until the decision is made and, if the project is not approved, to restore the previous condition.
Kosten	Fees apply. The amount of the fees depends on the investment amount or the administrative costs. The fees are calculated based on the Hamburg Environmental Fees Ordinance.
Verfahrensablauf	Those who have raised objections will also receive the decision with reasons.
Bearbeitungsdauer	Processing time is usually up to 2 months.
Frist	You will need the approval letter before you can start your planned project.
