| Teaser                           | If you want to transport people in a taxi commercially, you need an official permit.  |
| Volltext                         | To transport passengers commercially by taxi you need a permit (license). You can apply for this at the Authority for Mobility and Transport Transition. As part of the application process, it will be checked whether you meet the necessary requirements for the permit to be granted.   |

| Voraussetzungen                 | The safety and efficiency of the company is guaranteed. There are no facts that indicate that the applicant or the person appointed to manage the business is unreliable. The applicant or the person appointed to manage the business has the necessary professional qualifications (proof by certificate from the Chamber of Commerce). The registered office or branch is located in the country.   |
| Kosten                          | The fee is usually between EUR 100.00 and EUR 1,465.   |
| Verfahrensablauf                | Submit the application to the Authority for Transport and Mobility Transition, along with all required documents. The transport industry supervisory authority will examine your application and carry out the necessary hearing procedures to clarify all legal and substantive aspects. Once processing is complete, you will receive feedback on your application. If the answer is positive, the approval will be granted or revoked. The approval certificates will then be handed over to you.   |
| Bearbeitungsdauer               | The processing time is usually 2 weeks to 3 months.  |
| Frist                           | After receipt of the application, the decision on the application usually takes 3 to 6 months. The proof of the asset overview / equity certificate must not be older than 12 months.  |

| Hinweise          | Only one permit may be issued per applicant, unless more permits can be issued than there are applicants. Applicants who do not operate the taxi business as their main occupation, who have sold or leased their taxi business in the last 8 years, have not properly fulfilled their operational obligations. Legal entities under public law are deemed to be entitled to apply for approval without separate proof of the requirements. No taxi license is required for Velo Taxis. However, a special use permit from the responsible district may be required. The fees for issuing a taxi permit depend on the number of vehicles applied for and the duration of the permit. Payment is made exclusively by Girocard or a conventional credit card. Deadlines only begin to run when a decision-making application is submitted. If the application is complete, a decision must be made within three months. The deadline can be extended by three months if necessary. The processing time of the application may depend, among other things, on whether all documents relevant to the decision have been submitted or whether additional documents are required |

| Kurztext          | For the commercial transport of passengers by taxi, a permit or a concession must be applied for from the Transport Industry Supervisory Authority (Authority for Transport and Mobility Transition). The Transport Industry Inspectorate (Authority for Mobility and Transport Transition) checks the requirements for access to the profession.  |
