Volltext	Please note: The following information is based on the provisions of the Federal Social Security Act, which has since expired. Similar benefits are now provided under Book XIV of the Social Code (SGB XIV). We will be able to provide you with more detailed information on this shortly. Until then, please contact the office listed at the bottom of this page with any related concerns. If a disabled person dies, his or her relatives receive a death benefit. Amount: 3 times the pension to which the deceased was entitled in the month of death according to Sections 30 to 33, 34 and 35; however, the care allowance may not exceed Level II
Erforderliche Unterlagen	death certificate Evidence of family relationship (through stud book)
Voraussetzungen	Relatives are entitled to benefits if they were living in the same household as the deceased at the time of death. The following order of priority applies: spouse life partner Children Parents stepparents Foster parents grandson grandparents Siblings siblings If the deceased did not live in the same household with any of these persons, the death benefit is paid in equal order to the person whose maintenance the deceased was responsible for. If there are no beneficiaries, the death benefit may be paid to the person who paid for the last illness or funeral, or who cared for the deceased until death.

Verfahrensablauf	You can apply for the death benefit from the competent pension authority. Send an informal application by post or email to the responsible office. You will then be sent an application form. You can submit the required documents with the completed application.
