Volltext	For the commercial transport of persons with a rental car you need a permit. If you want to increase the number of vehicles for your rental car business you must apply for an extension from the relevant traffic authority. apply for permission.

Voraussetzungen	<p>You have a valid rental car license. You are personally reliable. You can demonstrate sufficient financial capacity. You can prove your professional suitability, for example in the form of a certificate of professional competence. The new vehicles for which the permit is to be extended are roadworthy.</p>
Kosten	<p>The amount of the fees depends on the number of vehicles and the duration of the permit.</p>
Verfahrensablauf	<p>Submit an application to your local transport authority and attach all required documents to the application. The authority will examine your application and carry out the necessary hearing procedures. You will receive a notification of the decision to extend your rental car permit. If applicable, you will be given the permit certificate(s).</p>
Bearbeitungsdauer	<p>Processing times may vary between the relevant transport authorities.</p>
Frist	<p>The clearance certificates from the tax office, the municipality and the social insurance provider and the professional association must not be older than 3 months. Your proof of equity certificate / additional certificate must not be older than 3 months. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary.</p>

Hinweise	<p>You submit your application to the transport authority of the respective independent city or district. Deadlines only begin to run when an application ready for a decision is submitted. The processing time of your application may depend, among other things, on whether all relevant documents have been submitted or whether additional documents are required. You</p>
