Volltext	You can reserve a grave (for example a row grave, urn grave or choice grave) in the event of a death or for precautionary purposes. A grave in a cemetery cannot be bought. You can purchase the right to use it. You will receive a certificate that proves your right to use it. You purchase the right to use it for a set period of time.
Erforderliche Unterlagen	The procedure is not uniformly regulated; please contact your local authority to find out about the necessary documents.
Voraussetzungen	The procedure is not uniformly regulated. The local authorities have their own statutes, from which the applicable requirements can be found. Find out about the requirements that apply in your case from the local authority.
