Volltext	If you wish to transfer your permit for the commercial transport of persons with a rental car to another person, you must apply for a permit.
Erforderliche Unterlagen	Contract concluded between the transferring and the accepting party Informal application with the following information: Reason why the rental car permit should be taken over Surname, first name of the applicant Information on residence and place of business for natural persons: date of birth, place of birth Number of vehicles, vehicle type, capacity of the vehicles used Service certificates or examination certificates Equity certificate / additional certificate Certificate of clearance from the tax office, the municipality, the social security office and the professional association The clearance certificates must be presented by the company, its legal representative and the person appointed to manage the business/traffic management. certificate of good conduct Extract from the Central Trade Register Extract from the Driving Aptitude Register (FAER) Vehicle list, if applicable rental contracts for rental vehicles or leasing list Proof of liability insurance for rental cars including risk code

	(WKZ) Business registration
Voraussetzungen	You can present a contract between the transferring and accepting party that shows the intention to transfer. They can ensure the safety and efficiency of the company. There are no facts indicating the unreliability of the applicant or the person appointed to manage the business. You are professionally qualified. You have your place of business or branch in Germany. In the case of legal entities under public law, the requirements are deemed to be met.
Kosten	The amount of the fees depends on the number of vehicles and the duration of the permit.
Verfahrensablauf	Submit your application to the relevant authority and attach all required documents. The responsible body will examine and process your application and conduct the necessary hearing procedures. You will receive a notification of the transfer of the rental car permit and the permit certificate will be handed to you.
Bearbeitungsdauer	The processing time is usually 2 weeks to 3 months.
