| Voraussetzungen                 | You have already applied for a permit to grow<br>cannabis. There are changes to the information you<br>provided in your application. The change concerns<br>information or circumstances provided in your<br>application (for example, contact details, statutes,<br>cultivation areas).   |
| Kosten                          | Fees apply. The amount of the fees is determined according to the fee schedule.  |
| Verfahrensablauf                | Report any changes to data via the online service.<br>Follow the online service's prompts to edit (change,<br>add or remove) your existing data. Please enter the<br>relevant changes (e.g. contact details, statutes,<br>cultivation areas) completely and correctly in the online<br>form. Supplement the notification of change with the<br>necessary evidence or documents, if necessary, for<br>example updated articles of association, extract from<br>the association register. Your documents and<br>information will then be checked for completeness and<br>plausibility. |

In addition, you must inform<br>the authority if there are grounds for refusal for a<br>board member or another person authorized to<br>represent your growers' association. Likewise,<br>decisions or fines that are relevant under the Trade<br>Regulation Act must be communicated immediately.  |

| Kurztext          | If the requirements for an existing application change,<br>these changes must be communicated immediately.<br>The changes that must be reported include, for<br>example: The club's headquarters Responsible<br>persons, such as board members, authorized<br>representatives or prevention officers cultivation areas<br>or delivery points In addition, the amended evidence,<br>such as an updated commercial register extract, new<br>articles of association or proof of power of attorney,<br>must be submitted or uploaded directly to the online<br>service. |
