| Volltext                         | A residence permit for employment as a skilled worker<br>with academic training gives you access to the labor<br>market in Germany. You can apply for a residence<br>permit if you have completed a university degree. If<br>you don't have a German university degree, your<br>degree must either be recognized or comparable to a<br>German university degree. You can obtain recognition<br>or a determination of comparability before entering<br>Germany. This residence permit is a temporary<br>residence permit. |

| Voraussetzungen  | You have a German university degree, or a recognized<br>foreign university degree, or a foreign university<br>degree that is comparable to a German university<br>degree. You have a job or a job offer for qualified<br>employment in Germany. The Federal Employment<br>Agency has approved the start of employment<br>(approval is usually obtained from the responsible<br>body). If you are 45 years or older, you must be able to<br>prove that you earn a certain minimum salary or have<br>sufficient pension provision. If necessary, you have a<br>professional license (e.g. license to practice medicine)<br>You can secure your livelihood and health insurance<br>coverage from your income without relying on public<br>benefits. There is no interest in deporting you. You<br>have a recognized and valid passport or passport<br>substitute  |

| Verfahrensablauf | You use the online service to apply for a residence<br>permit and upload the required documents. The<br>responsible office will then send you an appointment<br>for an interview. Please bring all necessary documents,<br>preferably in original, to the appointment. The<br>responsible authority will check your identity and<br>documents. The competent authority shall involve<br>other authorities where necessary. If your application<br>is approved, your fingerprints, signature and a<br>biometric photo will be taken to produce the electronic<br>residence permit (eAT). The responsible authority<br>commissions an external agency, the Federal Printing<br>Office, to produce your eAT. As soon as the eAT is<br>ready, you will receive a notification and can pick it up<br>in person from the responsible office. The responsible<br>office will schedule an appointment for you. If the<br>application is rejected, you will receive a rejection<br>notice with the reasons for the rejection. |

| Frist                           | Apply for a residence permit: at least 8 weeks before<br>your visa or residence permit expires. For permanent<br>employment contracts, the residence permit is issued<br>for four years and can be extended. If your<br>employment contract lasts less than four years, the<br>residence permit is issued for the duration of your<br>employment contract.   |

| Hinweise                        | If you are highly qualified, you may also be eligible for<br>the EU Blue Card as a residence permit. The relevant<br>authority will review this.   |

| Kurztext                        | A residence permit for employment as a skilled worker<br>with a completed university degree enables access to<br>the labor market in Germany. Foreign university<br>degree must be recognized in Germany and/or<br>comparable to a German university degree.<br>Recognition or determination of comparability can be<br>made before entering Germany This residence permit<br>is a temporary residence permit. |
