	Then the Central Housing Office is responsible for you.
Volltext	In the Central Housing Office, staff members advise <ul> <li>of the Office for Social Services</li> <li>the Association for Inner Mission</li> <li>the Bremische Straffälligenbetreuung association and</li> <li>the Hohehorst gGmbH of the Arbeiter-Samariter-Bund</li> </ul> <li>provide case-by-case and problem-solving advice on issues relating to accommodation in the event of homelessness. The central office is responsible for the central management of emergency housing for homeless people in Bremen, as well as support in the search for housing and the provision of housing (note: the central office does not act as a broker, does not manage a housing pool and cannot guarantee the provision of housing).</li>

	<ul> <li>are "acute" users of illegal drugs</li> <li>are receiving a drug substitute due to an illegal addictive disorder</li> <li>are discharged from a facility of the drug assistance system without a permanent residence, or who drop out of the measure, or</li> <li>who report themselves as self-reporters in an emergency shelter of the drug help system</li> </ul>
	are counseled at the Central Specialized Housing Office.
	The staff of the Office of Social Services also place people in housing suitable for the disabled and elderly and provide advice on housing adaptation measures.
	The Inner Mission operates a central hotel and boarding house control within the framework of the Central Specialized Housing Office, which provides assistance to the staff of the counseling center.
