Volltext	In some cases, the health insurance company provides some of the benefits, while certain services are paid directly by the Office for Care and Integration Bremen. As a rule, the granting is free of additional payments.

Voraussetzungen	A claim under the BVG (Federal Pension Act) is only based on persons from the 1st and 2nd World War: • injured soldiers • Widows and orphans of the fallen • Victims of war among the civilian population Exclusion: Soldiers' Pensions Act: Soldiers' Pensions - Responsibility in Düsseldorf, at the Federal Office for Personnel Management of the Bundeswehr - Care for the Damaged - Wilhelm-Raabe-Straße 46, 40470 Düsseldorf Exclusion: NVA (National People's Army)': Responsibility in Wilhelmshaven, at the Unfallkasse Bund und Bahn, Weserstraße 47, 26382 Wilhelmshaven
Kosten	The medical treatment is free of charge.
Verfahrensablauf	Members of health insurance companies receive a so-called "federal treatment certificate", which must be applied for at the health insurance company before treatment.
Bearbeitungsdauer	Approx. 1 day This depends mainly on how quickly the required documents are available in full.
