These are in particular for • Extracts from the register of associations - > the local court / register of associations • Extracts from the land register - > the land registry office • Civil status documents issued in Bremerhaven - > the registry office • Civil status documents issued in Germany - > the relevant registry office at the place of issue. Official certification of documents that are to be used privately is not possible. In this case, only certification by a notary public is possible.
