For the city of Bremerhaven: Fee for building permit (minimum fee 130,00 €) Fee for special use depending on the location and size of the area (2.50 € per m² per month). The fees are derived from the fee schedule for special use in accordance with the Bremen State Road Act in the city of Bremerhaven (special use fee schedule).
