For this purpose, a certificate is issued and handed over by the competent body if the relevant requirements are met, and you are entered in the official nationwide register of lawyers. Upon admission, you become a member of the admitting body. After admission, you may practice under the professional title "Rechtsanwältin" or "Rechtsanwalt".

Kosten	Fees are charged in accordance with § 192 of the Federal Lawyers' Act (BRAO) in conjunction with the Fee Statutes of the Hanseatic Bar Association Bremen.
Verfahrensablauf	Please contact the Hanseatic Bar Association Bremen with your request for admission as a lawyer. You can find the relevant application forms either here and/or on the website. These must be completed, signed and sent to the bar association with the required documents. If you have a corresponding post office box, you can submit the application via a citizen's post office box connected to the EGVP infrastructure. The way of e-mail and postal transmission is also open to you. You can submit original documents in person or by mail. These will be returned after processing.
Bearbeitungsdauer	The processing time depends on the completeness of the submitted documents and is approximately 3 weeks.
